Your statement for additional care settings

When I moved into the children's home, I believed I would finally be safe. Instead, the very risks my foster carer had warned social work about were ignored. Staff allowed me to stay overnight at my children's father's house, knowing I would be sleeping in his bedroom and that we were having an underage sexual relationship. They knew exactly why I had been moved into residential care, yet they failed to put any safeguards in place. The concerns had already been raised, but they still allowed the situation to continue. As a result, I became pregnant when I was only 15 years old. I firmly believe that if I had been properly protected, this would never have happened.

My children's father was also abusive towards me. He assaulted and controlled me, and when I told people what was happening, nothing was done to protect me. He was around 16 or 17 years old while I was only 15. Although the age gap may not seem large, I was still a vulnerable child who needed adults to recognise that I was being exploited and abused. Instead, the warning signs were ignored. He has since been imprisoned, but at the time no one stepped in to protect me despite knowing the risks.

There were five young people living in the children's home altogether, including me and four boys. I also remember being restrained regularly, often simply for expressing my emotions or speaking up for myself. Instead of being listened to or supported, I was physically restrained. This made me feel frightened, powerless and as though my feelings did not matter.

Looking back, I feel that social work and the children's home completely failed in their duty to safeguard me. My foster carer had done the right thing by raising serious concerns and asking for me to be protected, yet those concerns were ignored. The abuse continued, I became pregnant while still underage, and I was repeatedly restrained instead of cared for. Rather than feeling safe, I felt more neglected in the children's home than I had when I was living with my mother while she was struggling with drug addiction. The people who were responsible for protecting me failed to do so, and the impact of those failures has stayed with me ever since.
