Q1 | What is the name or location of the relevant care setting you were abused in?

- the abuse you experienced while living in this care setting
- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

While I was living at Alva Children's Home, there was a serious incident involving the staff and my boyfriend. I remember a member of staff being forceful towards me and shouting abuse at me. My boyfriend witnessed what was happening and intervened. The situation quickly escalated into a massive physical fight between my boyfriend and members of staff. I was absolutely terrified. The violence was severe, and I remember people being left with broken bones and black eyes. I was screaming hysterically throughout the incident and remember being pushed around myself.

The police eventually arrived, and both my boyfriend and I were arrested. I remember being taken through the street in handcuffs. It was an extremely frightening and humiliating experience. I never returned to Alva Children's Home after that incident. I was simply removed from the home and subsequently placed at Newlands.
