- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

When I was placed here I was 12 years old. This was a 3 week placement and I ran away from this care setting.

When I was brought back to this care setting I was punished by having my head banged together with another child I ran away with, doing physical training such as circuit training, a 5 mile run getting whipped with a stick. I was also made to scrub the floors and a staff member who worked here would flick his cigar on the floor and make me clean it.

Another staff member used to drag kids by there hair out of the rooms.

I was also punished with lack of sleep as the staff members would come in an disrupt it and make us put our feet on one wall and thumbs on another and if you refused they would physically beat you so you had to do it.
