Q1 | What is the name or location of the relevant care setting you were abused in?

- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

When I was placed in Glenavon, it was me and my brother. We were young boys and being away from my parents, me and my brother had to stick together.

At the start of this placement, the people around us were ok with ourselves but as we settled things turned horrible.

We would randomly get attacked by others, getting physically beaten up - punched, kicked, slapped and I suffered some bruising from these attacks.

These attacks would happen at least 2-3 times a month. It wasn't nice to experience at all, especially when it was at random, I never knew when to expect it or when the next time it was going to happen.

The staff members in this care setting never bothered to break these attacks up, not just with me but with any fights that broke out. They would turn a blind eye and walk away, they would say they never seen anything happen. It was very tough to go through this, especially when in them moments you wish you could rely on these staff members to come and rescue you.
