- the abuse you experienced while living in this care setting
- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

During my time in Kibble, I was one of the 'Day boys' where I'd go to school in the day and then return to Kibble after school. Some of the boys there didn't like that I had that sense of freedom to be outside of the facility. It got to a point where staff members turned physical on me. They would slap me around, kick me up the bum and restrain me in a very unlawful manner. They would fold my legs like a figure of 4 and pull my arms up my back. I remember shouting at them for hurting me and they would do it harder. They would restrain us with force like the Police would by grabbing us by the wrists and controlling us by a pressure point almost. This was really sore and painful and I'd feel the effects of this days later.
