- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

This YOI was a horrible time for me. The worst place I was ever in.

I had a similar experience to Kibble in here. I had to keep myself to myself in here. I didn't look at anybody, laugh at anybody and I barely spoke to anybody.

I did experience a few fights in here in order to protect myself and some of the other boys testing whether they could walk all over me or not.

The guards here were the worst. They were nasty and treated me poorly. They would degrade me and not help me in any way.

They didn't want to help anybody, I remember seeing this one boy press his cell call button for help and when the guards came to his cell they punched him in the mouth and told him not to press that button again unless he actually needs them. The guards did swear at this boy when saying so. This wasn't a nice thing to witness and I had to hide from watching incase the guards seen me watching and come and beat me up to.

My food was toyed and teased with in this facility and I would sometimes not receive my food because somebody else stole it. I remember getting really hungry and upset as to why it was me getting targeted.
