Chronology caveat

Some dates are approximate because the records are scanned, redacted and occasionally inconsistent. The chronology records both evidence supporting residence and entries that qualify or contradict aspects of the account. Exact admission/discharge dates should be verified against the original local-authority placement register or Children in Care return forms where available.
