Q4 | On the next page, please provide as much information as you can about:

- the abuse you experienced while living in this care setting
- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

Ann and Peter were very religious and devout Christians, and I was expected to live according to their beliefs and rules while I was in their care. I was made to attend Bible camp with their family and was pushed into religion from a young age, even though it was not something I wanted and was not something my parents had chosen for me.

My brother and I were initially placed there together, but he was abusive towards me and eventually had to be moved away. While I was living with Ann and Peter, I also experienced abuse from them. They were extremely strict and had rules about almost every aspect of daily life. The abuse I experienced there was mainly emotional, and I found the environment controlling and distressing.
