- the abuse you experienced while living in this care setting
- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

When I was placed here I was 14 years old.

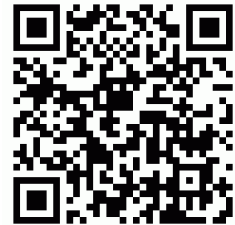
I remember doing the washing up in the night and after I was finished I was getting ready for bed and settling the other littler children and I went to my room and was then followed by 8 male staff members, they cornered me in the corner of my room and I was then touched, severely sexually abused and raped by them. They would force me to touch them as well. This targeted me as I was the oldest here and they took advantage of this.

This is something that still gives me nightmares to this day.

This happened to me most nights and 2/3 times a week. This has scarred me in so many ways that I'm now scared to leave the house.
