- the abuse you experienced while living in this care setting
- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

When I was placed in to Foster care I was around 12 years old. Being away from my family made me very unsettled. I was treated poorly and I felt like the care was low enough just so the foster parents could receive a paycheck. The foster dad was in the army and he would of a morning come in to my room and kick my bed to wake me up and this was every single morning. I suffered emotional abuse by for example: If I didn't eat all my dinner I'd be grounded or have my pocket money reduced. This would be because I was full or didn't like the food and this really made me unsettled as this was also a daily thing to happen. I'd used my manners in asking to leave the table and I was shouted at being told no.

Every month my parents were given an allowance for my clothing but they pocketed that and put me in clothes they wanted me to wear wearing cheap clothes from charity shops and this took away my self esteem. It knocked my confidence as a young child which led me to being bullied.
