- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

Here at Oak Bank I was against physically restrained quite badly. I would be locked away in cupboards and I also remember a staff member shoving a pet snake in my face knowing I was petrified of snakes.

I was also sexually abused here by being touched other people within this care setting and also staff members. My breasts were again touched, they would also attempt but I didn't let them, put their hands down to my private parts. This would mostly happen when I was being restrained. I would shout back at the staff members to stop touching me in areas they shouldn't.

I was also attacked by staff here purposely for them to be able to touch me and this just wasn't a nice feeling at all and I felt like a target for them at all times.

Overall my experience here has been quite scarring to me as still sticks with me today with clear memories of incidents.
