This placement was an all girl's school which I was hopeful in having a better experience. I had a better time here compared to my previous care settings but unfortunately I still endured some experiences that weren't nice.

There were some staff members that give me some verbal abuse.

I was also restrained and beaten up by staff members who were restraining me. I was left with a lot of bruising because of this but fortunately i hadn't drawn any blood.

There was other girls here who hated the staff members and how they treated us and they had built up so much anger towards the staff that they wanted to realise their own anger on them. The staff here were very unlawful to myself and many other girls here.

I also ran away from here too, I ended up not liking this place after seeing how severe the staff members would handle us and I just wanted out of here.
