- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

My time in Balrossie was a hell home. This was meant to be a professional care setting in which it never reached them standards.

I used to go home on the weekend and when leading up to the weekend the staff used to torment me in saying "your mum doesn't want you home" and then they used to ring my mum and tell her "he doesn't want to see her" Even when the staff members has beat me up and give me black eyes, they try to hide it from anyone at home therefore refusing me to let me go home to my family. I also had cuts on my head from them and if you never done as your told, the staff members would instruct the older boys to come and beat you up and they'd reward them with packets of ciggies.

In some cases I didn't eat my vegetables, They refuse me breakfast the next morning. This place used to get called "The Starvation Army"

I also remember the staff members coming in and waking me up by hitting me with "rubber tots" and I remember the staff member who done it, his name was Charlie. This happened on a daily basis.
