Your statement for additional care settings

This placement was awful. Because I was slightly older, I was placed in a flat within the home as part of what they called "independent living." In reality, I felt completely neglected. I was put in the flat and largely left to fend for myself. It was described as support and preparation for independence, but to me it felt like abandonment. I had always struggled to regulate my emotions, but the staff showed very little concern or understanding. Rather than trying to understand why I was struggling, I felt that I was simply labelled as a "bad child." I have since been diagnosed with ADHD, which has helped me understand some of the difficulties I was experiencing at the time. On one occasion, I attempted suicide and had badly cut my arms before falling asleep. When staff found me, rather than responding with care and concern, I remember being called "stupid" and being told it was because I had been drinking.

A man then came into the flat and stitched my arm. I assume he may have been a doctor, but I do not know who he was or what his role was. I was not taken to hospital, and I do not remember receiving any proper medical or emotional aftercare. I still have a severe scar on my arm to this day.

What stays with me most is that, even after something so serious, I felt I was simply left on my own again. There was no meaningful follow-up or additional support that I can remember. At a time when I was clearly extremely vulnerable and struggling, I needed care and intervention, but instead I felt abandoned. I was then nearly 18, so they just threw me out. There was no after care from social services or anything. I ended up in inappropriate relationships, abusing substances and ending up in dangerous situations.
