When I think back to my time at Murdock Bank Children's Home in Milngavie, I still feel the weight of the experiences I went through there. As a child, I didn't have the words to understand what was happening to me, but as an adult, I can see how deeply those moments shaped my life. One of the punishments I remember most clearly was being made to sit on the big stairs for hours on end. I would sit there in silence, afraid to move, not knowing when I would be allowed to get up. It wasn't just uncomfortable — it made me feel small, powerless, and constantly on edge.

There were times when I wasn't fed as a consequence for things I couldn't control. Going without food left me feeling frightened and ashamed, as though I had done something terribly wrong even when I hadn't. Bed wetting, something that many children struggle with, was met with hitting rather than understanding. I remember the fear of going to sleep, knowing that if I had an accident, I would wake up to punishment instead of comfort. On one occasion, I was hit so hard that an abscess I had actually burst. I didn't fully understand what was happening to my body, only that I was in pain and that the people who were supposed to care for me were the ones causing it.

Bath times were another source of humiliation. I was made to stand naked, exposed and vulnerable, with no sense of dignity or safety. These experiences left me feeling stripped not only of my clothes but of my confidence and sense of self. As a child, I learned to associate basic care with fear and shame, and those feelings stayed with me long after I left the home.

All of this has affected me massively throughout my life. The emotional impact didn't disappear just because the events were in the past. I carried the fear, the shame, and the sense of not being protected into adulthood. It influenced how I saw myself, how I trusted others, and how I navigated relationships and everyday situations. Even now, I still work through the long term effects of what happened to me at Murdock Bank. Speaking about it is difficult, but it is also part of acknowledging the truth of my experiences and the strength it has taken to move forward.

When I think about the nights I woke up to a man touching my private area, I still feel a deep sense of fear and confusion. This happened to me twice, and even now, as an adult, I struggle to fully understand how something like that could happen to a child who was supposed to be safe. At the time, I didn't have the language or the confidence to speak up. I only had the overwhelming feeling that something was terribly wrong and that I needed to stay quiet to protect myself. Those moments left a mark on me that I have carried throughout my life.

Waking up in the dark, disoriented and frightened, changed the way I saw the world. Instead of feeling secure, I learned to be constantly alert, always preparing myself for something bad to happen. I remember lying still, pretending to be asleep, hoping it would stop. The fear I felt in those moments stayed with me long after the incidents ended. It shaped the way I reacted to people, the way I understood trust, and the way I viewed my own body and boundaries.

These experiences affected me massively as I grew older. Trust became something I found incredibly difficult to give. I struggled to believe that people's intentions were genuine, and I often questioned whether I was safe, even in situations where I should have felt comfortable. Forming relationships became a challenge because I carried a deep fear of being hurt or taken advantage of again. I found myself pulling away from people, keeping my distance, and avoiding emotional closeness because it felt too risky.

As an adult, I can see how these events shaped my behavior and my ability to connect with others. I have struggled with relationships, not because I didn't want them, but because the fear and mistrust created by those early experiences made it hard for me to let people in. I often felt guarded, unsure, and hesitant to rely on anyone. Even when I wanted to build meaningful connections, something inside me held back, reminding me of the times when my safety was taken from me without warning.

These experiences have stayed with me throughout my life. Speaking about them is painful, but it is also part of acknowledging what happened and how deeply it affected me. It helps me recognize the strength it has taken to keep going, even with the weight of those memories.
