- the abuse you experienced while living in this care setting
- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

I found the environment very uncomfortable and distressing. There were frequent fights between the children, and I was involved in fights myself. The workers did not intervene, despite the fact that I was still dealing with significant trauma at the time.

On two occasions, serious riots took place. During one of these incidents, we barricaded ourselves inside a room and the fire brigade attended, using axes to break through the door. Windows were smashed and glass was scattered throughout the area. Afterwards, we were required to help clear up the debris, including pieces of wood and sharp pieces of glass.

I cannot now recall what caused the riots.
