Your statement for additional care settings

I was taken to a detention centre after getting into trouble whilst I was with one of my friends. Another friend of mine had broken into a property and gone on the run. The authorities mistakenly thought I was him and arrested me. Even after they realised they had the wrong person, they kept me there simply because I was his friend. I had not committed the offence they were looking for, yet I was detained for around three months.

From the moment I arrived, I was treated like a criminal. They shaved my head as soon as I got there. Every day we were made to run and march as though we were in a military camp rather than a place that was supposed to care for or rehabilitate young people.

Whilst I was there, I was assaulted by other boys in the showers. They beat me with wet towels, which was extremely painful and humiliating. Staff did not protect me or make me feel safe.

We were also forced to kneel on the floor with bars of carbolic soap and scrub the floors by hand. We were worked like animals and made to carry out harsh punishments that had nothing to do with helping us.

Staff would also put us "on report" for things we had not done, which meant we were punished unfairly and could end up staying there for longer. It felt as though they were looking for reasons to keep us there rather than treating us fairly.

The whole experience was cruel and degrading. Instead of receiving care or support, I was treated as though I was in a military prison. What has always stayed with me is that I had not even done anything wrong, yet I was still made to suffer through those three months.
