I began running away from home as a child due to abuse I was experiencing there. As a result, I was taken into care and placed at Burnside when I was around 11 or 12 years old. From the moment I arrived, I was emotionally distressed, frightened, and completely unaware of what was happening to me. I felt isolated and secluded from other people and had no understanding of my rights or how to protect myself.

At Burnside, I was living in constant fear. During the night, myself and other children would push our beds up against our bedroom doors to barricade ourselves in. We did this because a male member of night staff was entering children's rooms and sexually assaulting them. We all knew what he was doing, and we were terrified that it would happen to us. The fear was so intense that we felt we had no choice but to physically block our doors every night to try and keep ourselves safe.

Children were being sexually abused by staff at Burnside, and nothing was done to protect us. The food provided was inadequate; although food was technically available, it was often cold, hard, stale, and inedible. Many times, we went hungry. I began smoking at a very young age because staff allowed it, which shows the lack of care and safeguarding. I kept myself out of the staff's way as much as possible because I was scared of them and did not trust them.

Your statement for Care setting 2 continued

I remained at Burnside for approximately one year. At around 12 or 13 years old, I was then moved to Carolina House, Broughty Ferry Road. The abuse I experienced there was extreme and overwhelming.

Initially, when I arrived at Carolina House, things did not seem as bad and I began to settle. However, this changed when I was moved into the middle house. The staff there were extremely hostile, aggressive, and emotionally abusive. The way they spoke to us was intimidating and degrading. They had no time for us and showed no interest in our wellbeing. We were treated as though we were a burden rather than children in need of care and protection. The girls in the home were left to fend for themselves. There was no supervision or protection, and as a result, the environment was violent and unsafe. I was regularly bullied, picked on, and physically pushed around by older girls. Staff were fully aware of this but allowed it to continue. Their failure to intervene made me feel worthless and unprotected.

I was made to share a bedroom with another young girl. We actually got along, but we were both terrified to sleep. At night, an older boy who was also a child in the home would come into our room and sexually assault me. Staff did not stop this from happening. Instead of protecting me, I was punished. As punishment, staff would lock me in my bedroom or place me in another room that contained only a mattress on the floor. I was kept there for up to three days, in silence and darkness, which was traumatic and deeply damaging. This isolation felt cruel and inhumane and caused severe emotional distress.

We were constantly locked inside the home. I remember a period where I was not allowed outside for over a month. I felt like I was losing my mind from the confinement and lack of freedom. The bullying from other children continued, with name-calling and physical fights, and again staff failed to intervene or protect me. While staff were not always overtly aggressive, they consistently turned a blind eye to the abuse taking place.

I was never given the correct support, care, or protection. I was a child and a victim, yet I was treated as if I was the problem. After I left the isolation room, the same boy went on to sexually assault my friend Tamara Shaw, who was also a victim of the same individual.

I also recall that Helen Andrews was impregnated by a member of staff at Carolina House. Her brother, David, was also abused. There were many children in this home who were being sexually abused. We were being groomed, manipulated, and assaulted while those responsible for our care failed to protect us. The abuse was widespread, and the way we were treated was cruel and neglectful.

Since my time in care, I have suffered from ongoing anxiety and depression. The trauma I experienced has stayed with me throughout my life. I will never forget what happened to me, the fear I lived in, or the abuse I endured. These experiences have permanently affected my mental health, my sense of safety, and my ability to trust others. The impact of what happened to me in care will stay with me for the rest of my life.


