- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

I was put in here as a child that never got in trouble. My parent's couldn't accommodate me and that's why I was placed here. With confusion as to wondering why I was there was always the question.

The majority of the staff here were generally ok, there was never really an issue with day or night staff.

An experience I remember was being instructed at 2am in the morning and took downstairs in my boxer shorts. We was told to admit who stole the watch. It was the nanny's watch that went missing and we were blamed for it. But we weren't blamed by other kids, it was the staff members trying to bribe the answer out of the kids in saying "we've been told it was you, somebody said it was you" in order for us to slip up with it being so late at night and our sleep disrupted.

When I look back at this, this was mental torture, sleep deprived messed with us physiologically.

Getting us up at 2am, the staff members knew they would try and get an answer out of us by catching us off guard.
