- the abuse you experienced while living in this care setting
- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

While I was living at the home, I got a beating from two of the boys. After that, I started wetting the bed and I felt really intimidated by them.

None of the staff were nice to me. I was also restrained by staff and held down on the floor.

One night I wet the bed and they made fun of me after feeling the sheets and realising what had happened. I found that really embarrassing and upsetting. For me, it was more mental and emotional abuse than anything else.

There was also a boy called Mark who I used to live alongside in the home who was one of the boys that beat me up. Later on, I ended up working with him and he fractured my jaw. I had to leave that job because I couldn't carry on working alongside him. All of this had a big effect on me, especially the way I was treated and how intimidated and embarrassed I was made to feel.
