- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

Similar to the previous care setting, the main form of abuse I experienced was neglect. I often felt that many of the staff were simply there to do a job and collect a wage, rather than because they genuinely cared about the children they were responsible for.

There was very little sense of emotional support, understanding or compassion. As a child in care, I needed people who would take an interest in me, listen to me and try to understand what I was going through. Instead, I often felt ignored and as though my needs did not really matter.

The lack of genuine care had a lasting effect on me. It reinforced the feeling that I was not important and that the adults who were supposed to look after me were not really interested in my wellbeing. I remember running away from this care setting a lot. A big part of the reason was that some of the people there were horrendous to be around, and I simply did not want to be in that environment.

Running away felt like a way of escaping from a place where I did not feel comfortable, supported or safe. Rather than wanting to stay there, I often felt that getting away was the only option available to me. My mother fought to have me returned home, but she was told that I was safer remaining in the care placements. Despite this, I did not always feel safe or settled there. I would often run away from the placements and, at times, I would hitchhike in an attempt to get away.
