Your statement for additional care settings

Unlike the other care settings, I could not run away from this secure unit because I was locked in.

While I was there, I had a sexual relationship with another person in the unit. Looking back now, I do not believe that should have been allowed to happen, particularly given how vulnerable I was at the time.

I was placed in a secure environment with people who had committed very serious offences, including murder. In my view, looking back, I should never have been placed in that setting. I was a vulnerable young person and being in that environment had a serious impact on me.

You were locked in your room and provided with food, but there was very little that helped with your emotional or mental wellbeing. I believe that being confined in that environment pushed my mental health over the edge, and I have struggled with the effects ever since.

At one point, I attempted to take my own life. The whole experience was horrendous. The person in the bedroom next to mine had committed murder and would regularly become extremely aggressive and disruptive. Being surrounded by that level of fear, instability and distress had a profound effect on me. Looking back, I believe the placement was completely unsuitable for someone in my situation and significantly contributed to the mental health difficulties I have experienced since. The police weren't much better as I would be picked up manhandled.
