I was placed in foster care with a man named Peter Corbitt and his wife. During the time I lived there, their children bullied me very badly on a regular basis. The bullying was not just verbal—it became physical, and I was attacked repeatedly. On one occasion, they beat me so severely that it left me terrified and in pain, and it ultimately led to me leaving that home. That incident has stayed with me ever since.

I was treated like a second-class citizen in that household. I was not allowed to eat at the same table as them and was made to sit separately, which made me feel isolated, unwanted, and different. It reinforced the feeling that I did not belong anywhere. I strongly felt that they did not genuinely care about me and were only fostering me for the money. No matter what happened, they would always take their children's side, shouting at me and blaming me, even when I was the one being hurt.

The abuse became so severe that one time, after being badly beaten again by the children, I ran away from the home. I felt I had no other option. I contacted ChildLine, which shows how desperate and unsafe I felt, and I was eventually taken back into care.

These experiences have had a lasting impact on my mental health. I continue to struggle with anxiety, trust, and feelings of worthlessness, which still affect my life today.

Your statement for Care setting 2 continued

My time at Coulpark was an awful and deeply distressing experience. When I first moved there, I was the only girl, which made me feel isolated and extremely vulnerable from the beginning. I was already struggling with depression, and there were several times when I self-harmed, but the staff did not offer me any support or intervention. Instead of helping me, they ignored clear signs that I was in serious emotional distress.

I was also medically neglected on many occasions. One incident that has stayed with me is being left to lie in my own sick overnight without any care or assistance. I felt completely abandoned and worthless, as though my wellbeing did not matter at all. Because I was not getting the help I needed, I ran away multiple times, as I felt there was no other way to escape how I was being treated.

During my time there, I took an overdose and had to be admitted to hospital for a few weeks. This shows how unwell I had become while living in that environment. While I was there, one of the boys in the home sexually assaulted me. I reported this to the police and had to give a statement, which was extremely difficult and traumatic.

The staff in the home did their best to cover up what had happened, and instead of protecting me, I was the one who had to move placements. The boy who assaulted me was allowed to stay. This has had a lasting impact on my mental health, and I continue to struggle with trauma, trust, and feelings of neglect and injustice to this day.

I was at Whick for around one to two months during my time in care, and it was an awful experience. From the beginning, I did not feel safe. My room was broken into multiple times, which left me feeling constantly on edge and without any sense of privacy or security. I was also physically assaulted by some of the other children in the home. They bullied me relentlessly, and although the staff were aware of what was happening, they chose to turn a blind eye and did nothing to protect me.

I became so frightened that I was often too scared to eat. I remember one occasion where I went without food for three days because I was too afraid to go near the dining area. The other children would spit in my food and put dirt and substances into it right in front of staff, and no action was taken. This made me feel humiliated, degraded, and completely unprotected.

There were also multiple incidents where the other children smashed my plates and belongings, again in front of staff, who did nothing to intervene. I felt completely powerless and targeted.

This was one of the worst experiences of my life. It has had a lasting impact on my mental health, leaving me with ongoing anxiety, fear around others, and difficulty trusting people. Even now, I carry the trauma of how I was treated and the complete lack of protection I experienced.
