Q1 | What is the name or location of the relevant care setting you were abused in?

Q2 | When were you abused?

For example: a single date, an age, or an approximate time or time range.

Q3 | Who was involved in your abuse?

For example: a member of staff, a peer or someone outside the care setting.

The information you provide will be used by Redress Scotland to make a decision about your application. Redress Scotland will use the "Assessment framework" to help them do this, available on [gov.scot](https://www.gov.scot). Please be aware that it contains graphic descriptions of abuse.

Q4 | On the next page, please provide as much information as you can about:

- the abuse you experienced while living in this care setting
- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

You can continue on additional pages if you need to.

Part 2 of the application form provides more information about what you may want to include.

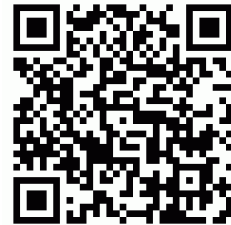
Your statement for additional care settings

This was my longest placement, and I remember it being a very strange and confusing environment. The carers were extremely religious, and looking back, I personally believe that the way they lived and imposed their beliefs felt cult-like. I have since spoken to another girl who was placed there with me, and she has said that she feels the same way.

I do not remember experiencing physical abuse while I was here, but I feel that I experienced psychological and emotional harm. We were made to attend church and expected to follow their religious beliefs and way of life. They would tell us that God was going to come and get us and that the devil would take the children who were bad. When it came to New Year, they would talk about the world ending, which was extremely frightening for me as a young child. I did not fully understand what they meant, and it left me feeling scared and anxious about what might happen. This has stayed with me into adulthood, and because of those experiences, I no longer celebrate New Year. I was only a young child, and I did not understand what they were telling me or why. I remember constantly feeling confused by what was happening around me. Being exposed to these frightening ideas at such a young age had an impact on me and made the placement feel unsettling and frightening.
