- the abuse you experienced while living in this care setting
- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

I was first placed into care at a very young age. My mother struggled with alcoholism, and my father had left her with six children, all under the age of seven. I was the youngest of the six children. I believe that two of my siblings were placed in care with me at this time.

Because of how young I was, I have very few memories of this placement, and much of what I know has been told to me by others. One memory that has remained with me is suffering an injury in which a nail went through my head. I do not know how the injury happened or the circumstances surrounding it. I remember being dressed in a kilt and being taken to hospital for treatment.

My childhood involved repeated periods of being taken into and out of care. My mother had a pattern of taking us out of care, only for us to later end up back in care again. I believe this may have been what happened following this particular placement and may explain why I was moved from there. However, as I was very young at the time, I cannot be certain of the exact circumstances. I have tried to be clear about the difference between the events I personally remember and the information I have subsequently been told about my early childhood. The lack of clear memories makes it difficult for me to provide exact dates or a complete account of what happened during this period of my life.
