- the abuse you experienced while living in this care setting
- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

I do not know why I was put here. I was taken to a children's panel and then left there. I felt so lonely during my time there. I was locked in and did not get to see my siblings for nearly two years. Being separated from my family for so long was heartbreaking and made me feel abandoned and completely alone.

I also lost out on my education because my needs were neglected. There was a teacher there, but she did not teach us properly. She was not interested and simply let us get on with whatever we wanted instead of making sure we learned. As a result, I never received the education I should have had. Even now, I struggle with spelling and this has affected my confidence and my ability to find and keep work.

I was frightened all the time. The other children bullied me, but the staff never stepped in to protect me or show that they cared. They were meant to keep us safe and look after us, but instead we were left to one side as though we did not matter. I felt neglected, uncared for, and completely forgotten.
