- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

When I was younger and living in care, I suffered from bedwetting. I remember that when this happened, the bedding was not always changed and I was told to lie back on the wet bed. I also remember being made to lie on a cold floor and being put into a cold bath. As a young child, I found this frightening, humiliating and distressing.

I also remember being physically punished by members of staff. I was spanked when staff considered that I had been naughty. There were also occasions when food was withheld from me as a punishment. I remember being told that if I had been a "naughty girl" I would not be given anything to eat, including breakfast. These experiences have stayed in my memory. I was a young and vulnerable child and I needed care, reassurance and understanding. Instead, I remember feeling punished and ashamed, particularly over things such as bedwetting that I did not feel I could control.
