Your statement for additional care settings

I was around 4 years old when I was placed here. I was placed here with my brothers and sisters. Unfortunately we weren't in the same rooms as I was a little older than them. When they were in my dorm, I used to barricade us in the room so we were never separated but I was told off a few times for this.

I was also scared here because there was a girl here who was placed in my room who has burn scars and it really scared me.

The punishment with food would be if you didn't eat your breakfast you'd get it for your lunch and if you didn't eat your lunch you'd get it for your tea. This to me was wrong giving 2nd hand food back to us. I felt we were neglected with that.

There was also a punishment which was "the slipper" fortunately I was never taken away for that but god knows what that was or would have been, it didn't sound nice at all.

In terms of clothing, I never had clothes brought to me by my mum or dad which resulted in a big accessible wardrobe which clothes were given to us not by choice and we had to accept whatever was given. There was the odd time I was able to choose what I'd like to wear.
