- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

I was a baby when being placed here. I started my life pretty much here and I was the youngest.

I remember being in villa 5 and it being a big house with 15-25 kids in it.

I suffered physical, emotional and sexual abuse at this unfortunate young age. I was beaten and locked up in cupboard. The other kids teased me in saying my mum was dead when she wasn't. I was also threatened/teased that I'd be thrown out the window and also thrown in the river next to our villa. There was a bully in here that used to steal my things every Sunday, whatever my mum has brought me in would get stolen. With all this happening and fear being caused, caused me to start bed wetting.

The sexual abuse was endured by the other kids. They took my pants off and layed me on a bed and played with my genitals and made it in to a game of doctors and nurses but this was another another extreme. To have experienced and suffered this at a young age is traumatising.

Another incident occurred in the woodland during playtime.

This other 1 lad would love pressing my buttons and making me cry and wee myself and he would laugh at me.

I feel the duty of care in this facility was below the par and for me being so young in here, there was no additional extra precautions in place in terms of looking after me
