Your statement for additional care settings

When being placed here after Kerelaw and this place was horrendous for me.

In here I'd be woken up with a wet towel being flicked at me from staff members. This was making me sleep deprived in ways I never realised.

The showers here were dreadful, there was never any hot water so it was always cold showers. They neglected me leisure time of playing pool by a staff member being in charge of who went in and I would be told no for no reason at all.

There was also a smoke room here for the older boys who smoked and if you was naughty you'd be thrown in there and slapped and pushed about by the boys.

I also remember a time I'd refused to go and pick some mushrooms and again I was put in the smoke room with some boys and they held a knife to my throat. I also had part my head and eyebrow shaved by boys in the smoke room too. The staff used to throw us in this smoke room knowing what was happening to us and they never done anything about it. You'd walk out there bruised, a busted nose... anything and nothing was never done about it.

When trying to talk to the staff about it I was told to "shut the **** up and play the game"

I was also refused home visits to my family and they would blame this on me doing something I hadn't actually done.

I was also blackmailed by the staff members in saying "if you don't do this you wont be going home at the weekend"

There was a staff member called "Stuart" who would take you away for the day and if the other boys knew about it they would tease you with comments about it as Stuart was a known character here. The most Stuart done to me was give me a pat on the backside for something good I'd done.

This placed overall has me living in constant fear and on edge.
