- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

When I placed here I was around 12/13 years old. This was only a short term placement for me but during this period I still suffered mental & physical abuse from the staff members and the other residents there.

I was a clean boy and at the time the staff members made you clean up and it wasn't asking, it was telling. When somebody has smashed something like a glass or cup, other people including myself would be told to go and clean it up and if we refused we'd be threatened by the staff members to put us in with the older boys to get a smack.

I was threatened by the staff members because of refusing to do their work, they'd put me in the gym hall to get smacked and slapped about by the other boys and if I didn't fight back I'd be bullied more and other people would then try and do it to me.
