Your statement for additional care settings

I was placed here because I received a fine that I couldn't afford to pay. As a result, I was arrested and sent there. I was only 17 years old, had never been in a place like this before, and I was terrified. The abuse I experienced was mainly mental, but there was also physical abuse. Whenever we had been out of our cells and had to return, the officers would follow me into my cell. They took advantage of the fact that I was scared, vulnerable, and didn't want to cause any trouble. They would slap me, hit me on the back of my head, and kick me. It happened regularly, and every time they shouted, "Get in that cell," I knew I was going to be assaulted. At first, I tried to deal with it on my own, but it eventually became too much. I lived in constant fear and didn't want to tell my mum because it's not something you want your mum to know. When she came to visit, I had bruises on my face and I was in tears. She could see I wasn't coping, and I begged her to get me out. What hurt the most was that the abuse came from the officers. When you are sent somewhere like this, you expect to be looked after and kept safe. I expected trouble from some of the other boys, not from the very people whose job it was to protect me. They were grown men bullying and abusing a frightened 17-year-old who couldn't fight back. I was not a criminal. I was only there because I couldn't afford to pay a fine, yet I was treated like I was nothing. This place broke me. Instead of helping me move on from a minor offence, the people responsible for my care traumatised me, and the impact of what happened has stayed with me for the rest of my life. The officers seemed to get a kick out of abusing us. It felt like they enjoyed intimidating, humiliating, and hurting us. They would laugh, smile, and treat it like it was a game, while we were left frightened and powerless. We were just young boys, and they abused their position of authority for their own amusement. Sometimes two officers would come in. One wouldn't even do anything, he would just stand there and laugh at me whilst the other officer hurt me. It was cruel, degrading, and something that has stayed with me for the rest of my life. The things I witnessed there also had a lasting effect on me. It had turned me into a different person. I saw other boys locked up, and I even saw someone who had hanged himself. Seeing things like that at such a young age was deeply traumatic. The whole environment was frightening, and instead of feeling safe, I was constantly surrounded by fear, violence, and despair. Those memories have stayed with me ever since and only added to the trauma I was already experiencing. I do not trust any officers. A couple years later, my mum passed away. The trauma I was already in combined with this led me to drugs and it lasted 15 years. My life was never the same after this place. I was going through life thinking how much easier it would be if I overdosed, it was get me out of the position I was in.
