

Chronology of Care

William McChesney - Kibble placement evidence

Chronology status: The supplied documents establish a committal date and a later admission to Kibble, but they do not record a discharge date. The chronology therefore remains open-ended after 19 May 1977.

Placement summary

The documents support the conclusion that William McChesney was admitted to Kibble on 19 May 1977. The Kibble-issued summary identifies Kilmarnock - Ayr Division as the social-work authority and records a prior committal date of 29 October 1976. Appendix 1 is a contemporaneous-looking handwritten admission-register extract, while the record-details sheet is a later typed transcription/summary. The two sources agree on the key identifiers and dates.

No discharge date appears, so the documents do not establish how long the placement continued. They also do not state the precise legal order, identify an individual social worker or residential unit, or provide the historic Kibble address.

Abuse and impact chronology

No incident of physical, sexual or emotional abuse; neglect; disclosure; complaint; institutional failure; mental-health impact; injury; substance use; or later personal impact is recorded in either supplied document. No abuse chronology can therefore be constructed from these pages.

Contradictory, neutral and uncertain entries

Entry / issue	Context
Medical: N/A; X-Ray: N/A	Neutral administrative fields. They do not show that no medical care ever occurred; only that no such details are included in this summary.
Previous School: No	No previous school is identified in the typed summary. The handwritten register is partly obscured and should not be used to infer a school name.
Abbreviated 'P' in Appendix 1	Meaning is not defined. It should not be converted into a particular statutory section without corroboration.
Current Kibble address	133 Finnieston Street, Glasgow, G3 8HB is printed as the current organisational address and is not expressly described as the 1977 residential address.
Heavily redacted register image	Most neighbouring content is blacked out. This limits contextual interpretation but leaves the applicant's visible row legible enough to corroborate the typed summary.

Records needed to complete the chronology

Priority	Record sought	Purpose
1	Complete Kibble admission/discharge register entry and resident case file	Confirm discharge date, placement duration, unit, leave/absconding, staff and aftercare.
2	Kilmarnock/Ayr Division social-work file	Confirm authority, placement decision, funding, reviews, named workers and transfers.
3	Children's Hearing / court papers dated around 29 October 1976	Identify the legal basis and terms of committal.
4	Education and medical records during the placement	Corroborate residence and identify health, school or safeguarding evidence.
5	Incident, punishment, complaint, inspection and police records	Investigate any allegation of abuse or institutional knowledge, if relevant to the application.

Source limitation: This chronology is based only on Appendix 1.pdf and William McChesney Record Details.pdf. Calculations and inferences have been labelled; unsupported details have not been supplied.
