- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

When being placed here I was 5 years old. I remember having to wake up every day and having to make my bed and it was like a army camp.

I was bullied quite a lot here, being verbally abused and physically hit by the other kids. The staff members used to actually see this happening and do nothing about it. If I was to react or lash out then I'd be the bad person for it. But no child should have to go through this.

I also remember being physically restrained and pinned down by staff members having my arms and legs twisted until I was showing physical pain and my legs and bum would be slapped until I was complying with the staff members and this happened on many occasions to me.

I also witnessed this happening to other kids in here too.
