- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

I was placed here in my teenage years. The first handful of months was ok to settle in to before the abuse started to happen. The staff would physical abuse us by beating us, throwing wooden ashtrays at us, snooker balls and cues, hit me with sets of keys and physically beat me.

I'd always run away as I didn't end up liking this care setting. When I was brought back, the staff would organise for the other older residents to beat me up, this would sometimes range from 2-5 people depending on how many jumped in to beat me. I was only a little teenager and couldn't defend myself.

I was left bruised from this.

Sometimes of an evening you could ask for something to eat, sometimes it would be a no and some nights I was allowed. This would leave me going to bed hungry sometimes.
