Q1 | What is the name or location of the relevant care setting you were abused in?

- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

I am not entirely sure why I was sent to this family. I can recall my dad being sent to jail and the police attended my home.

I was there for around 2 weeks. During this time, I was sexually assaulted by the couple's middle child. His name was Gary, he was around 17 at the time and I was 5 or 6 years of age.

Gary, on several occasions, would pull his pants down and force me to perform oral sex on him. It was always behind closed doors, I was terrified and I was made to believe it was normal by him. It had never happened to me before so I didn't know if it was right or wrong. Gary would keep telling me it was a game.

I can recall telling my mum about it when I returned home. She told me it wasn't right, I believe Gary's parents were informed about it and the police were involved. I did try and go back to the Police in 2014 and 2019, I was informed they would not investigate it was apparently I provided a no comment interview when I was 5 or 6 years of age - I cannot recall this.

The events have had a lasting impact on me. I relied on alcohol to help me cope for most of my life. I drank every single day at one point. I can recall telling a social worker about the events, but nothing ever happened.
