Stewart had broken the same backdoor window at 12:15 PM today and jumped out. He later returned by himself at 3 PM and reported as the owner to get in, he had said that he didn't want to go to his review which was held at 1:45 PM. Stewart and [redacted] were visible all evening and took the opportunity to agree breaking the same incident when the children were getting medical attention. Stewart claims he has a large tin of glue in the grounds of his house and that could be the reason for him absconding.

Stewart's mother rang evening (4/9/82) to report Stewart missing from home (where he'd gone on short weekend leave). She asked that we report him missing and added that, should he be apprehended, she wanted him returned to

Burnside and not brought to his home. In early evening Stewart, with [redacted] who was on day leave, were seen hanging around Burnside. Staff tried to persuade Stewart to come in to work but he declined; however, he sent [redacted] in to say that he didn't want to return home to complete his weekend leave. Staff asked [redacted] to tell Stewart it was o.k. for him to come back to Burnside for the rest of the weekend. [redacted] duly went to report this back to Stewart after which both boys were expected to come back into Burnside. However, they both went off and, at 8am when day leavers are due in, neither [redacted] or Stewart appeared and so were reported missing to both Duty Social Worker and Police.
