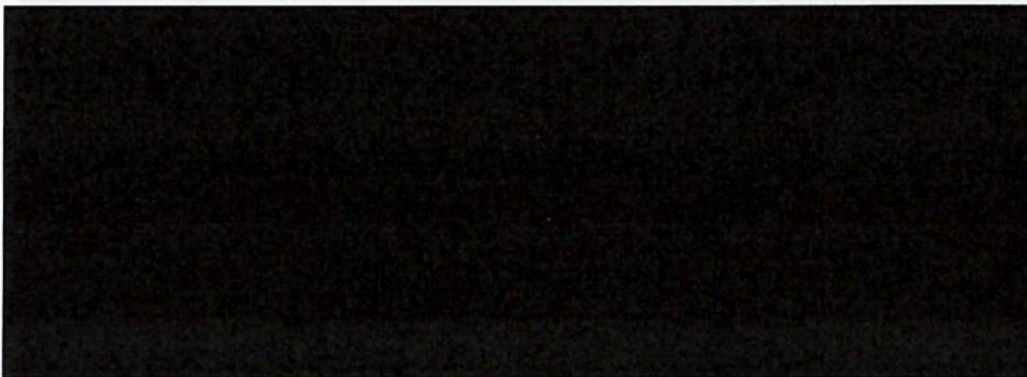

13/01/03 IRD, re – William wishing to speak to someone regarding things he was not happy about whilst in the care of [REDACTED] foster carers. Outcome = Eleanor Arnott, social worker and DC Sandra Hutton will meet with William to hear what he has to say. **See attached Detail Record.**

16/01/03 William brought to Seymour Lodge by his current foster carer [REDACTED] William asked that Mr [REDACTED] be present when he spoke with Eleanor Arnott and DC Sandra Hutton.

William said he wanted to make a complaint against previous foster carers called [REDACTED] [REDACTED] William could not remember their surname, not their address, but said they lived in Dundee at the time. William said that whilst living with them he got hit by [REDACTED] but [REDACTED] was O.K. as she still fosters children but [REDACTED] was not allowed to look after children anymore as lots of other people have said that he hit them. William was asked where he got this information and he said, he discussed it with his social worker Ingrid Von Arnim.

William spoke in general terms about being hit by [REDACTED] but when this was pursued further some of the incidents he described were off being pulled by the sleeve of his jacket and did not amount to physical chastisement.

William described a situation when he was in bed watching TV and [REDACTED] told him to switch it off, but he told him that [REDACTED] said he could watch it for another 5 minutes, however [REDACTED] told him to switch the TV off and stop being cheeky then hit him on the back.

William described another incident when he was playing in the garden with 3 other foster boys and they started fighting. William went into the house to tell [REDACTED] but was told to stop telling tales. [REDACTED] was sitting on a chair and William was standing in front of him when [REDACTED] allegedly pushed him with the top of his foot which resulted in William falling onto the couch.

William described a time when they were on holiday in Newcastle. William and 3 other foster boys were out playing and were heading towards a nearby hill to play when [REDACTED] arrived and told them to return to the house. The boys said no and scattered but [REDACTED] managed to catch William and pulled him back to the house by the sleeve of his jacket.

William was asked to describe the worst thing that happened to him whilst in the care of [REDACTED] and he said, "when I was put in the boot of the car". William was asked to describe the car and what type of boot it had. What William described was a large car, similar to a people carrier, that has a door at the back as well as at the side. William said on this occasion he had to enter via the back door and sit at the back of the vehicle, however, he did not like sitting at the back as you went up in your seat when you went over a bump. William was asked to describe what happened before he entered the car. He said that [REDACTED] had to drop [REDACTED] off some place and he and the other foster boys that stayed there did not want to go with them and refused to leave the house or get into the car. [REDACTED] pulled William and another boy by the sleeve of their jackets towards the car but William said he grabbed onto the fence and still refused to go. [REDACTED] continued to pull him towards the car by the sleeve of his jacket and made him go into the car by the boot (back) entrance instead of the side entrance.

William described another incident where he and the other foster children were carrying on and a pillow was thrown at them.

William presented as a young boy who saw things in black and white and could not grasp the concept that life has grey areas. He also did not have any understanding that his behaviour could have contributed towards the overall situation at the time of the alleged incidents.

Event: Session with William

I took William out in the car to talk. William raised the subject of the allegations he has made against [REDACTED] immediately. I explained to William what can happen when a child makes allegations against people who are looking after him, whether this is parents or carers. I explained to William that if the police became involved he would probably have to be interviewed by them with a social worker present as well. I asked William what he thought should happen. He said that at the very least [REDACTED] should never again be allowed to foster children. I asked him if he thought anything more than that should happen. He said he was unsure and that he would like to think about it over the Christmas Holidays.

I asked William what had prompted him to talk about the [REDACTED] at this time. He made a reference to his knee. He said he had an injury to his knee which he incurred when [REDACTED] threw him off a chair, and from time to time it still hurt. It had been hurting when he made references to the [REDACTED] to [REDACTED] last week.

I also asked William whether he had been scared that the [REDACTED] might hurt him when he was placed there. He said he had been reassured during the introductions that this wouldn't happen, as they had made it very clear that they did not hit children.

I asked William how he felt now about his time at the [REDACTED]. He said he didn't really feel anything. It was over and in the past and could not happen now.

I told William that I would take his views back to my manager.

William told me that he had enjoyed his respite weekend with [REDACTED] and hoped that he would be able to go again.

I also discussed with William the continuing difficulties with the unreliable contact with his parents. I suggested to William that perhaps contact should be reduced, so that he saw each parent on a bi-monthly basis. William was adamant that he did not want the current arrangements to be changed. I informed William that his Review Children's Hearing was in January, and we would need to discuss this issue with the panel.

William said he wanted to focus on completing his lifestory book (captioning his photos on the computer) in the New Year.
