UK General Data Protection Regulation as supplemented by the Data Protection Act 2018 (GDPR)

Please find attached all information held by Social Work Resources regarding your client, James Haney.

The Council is withholding some of this information from your client because your client's right of access has been restricted in relation to that information.

Your clients right of access is restricted where we are unable to comply with the request because to do so would mean disclosing the personal data of a third party, where we do not have their consent and, in all the circumstances, it would be unreasonable to give you that third party's personal data (paragraph 16 of Schedule 2 of the Data Protection Act 2018).


Application to court

In addition to your right to complain to the DPO and/or the Information Commissioner, you can apply to court for it to determine whether the council has, in the way that it has handled or responded to your request, has infringed your right of access. If the court decides that the council has done so, it may order it, in order to ensure that it does comply with your right, to

- take steps specified in the order or
- refrain from taking steps specified in the order.

You should take your own independent legal advice about going to court.
