Comment	Follow up appointment through Staff Mental Health Check in service - initial call made by Brenda on 29th March 2021. Finds she has difficulty managing emotions. Attended a one week mindfulness group at Gartnavel which really helped but there was no follow up. Had time off last year for fibromyalgia. Struggles to continue in employment have to rest a lot. In the last 3-5 years needs to sleep during daytime otherwise becomes very anxious and tearful. Avoids leaving the house due to fear - has a 'need to escape' when outside. Described history of abuse - mum was an alcoholic. Also was held hostage by a man for 3 months when age 14. Had counselling for this 3 years ago. Reported the incident to the police who were helpful. This is NOT something she is seeking help for now in terms of trauma. However, this is what has left her with the need to escape /get away from anxiety provoking situations. Had a breakdown age 30 and described self then as "really unwell" had just come out of bad marriage. As well as needing an 'escape' plan when out she also tries to be alone as much as possible and not have anyone to visit. Then is able to "just sit" however, recognises that she then ruminates so tries to keep busy, with her mind occupied. Does like company of others and being in groups in other circumstances so not socially anxious. The only COVID related issue is due to the restriction of not being able to get out into the countryside as much as she would like and not being able to see her daughter who lives in Dundee. No fear of COVID itself. Feel "abandoned" by GP -has never offered anything other than meds for anxiety and she is unable to take anything as is too sensitive to them and intolerant. Very rarely drinks due to experience of alcoholic mother and has never taken drugs. No current suicidal ideation. Plan: Suitable for Occ Health CBT - I will make the referral.
