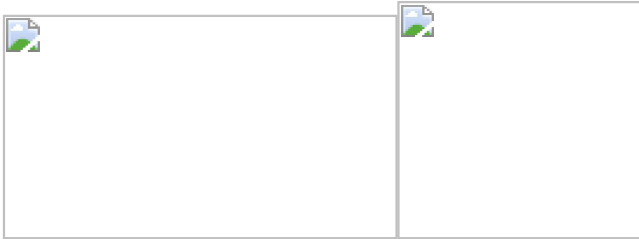
If we haven't received a response within the stated time frame. We will have to consider escalating the matter. However, this is not our intention and hope that we can work together in the best interest of our client.
