NOTES

At the children's hearing the child or his parents may or may not accept the grounds for bringing the child before the hearing. If the grounds are accepted by the child, and his parents, if present, the children's hearing will discuss and consider with the child and his parents what is best for the child. If any of the grounds are not accepted, the hearing may either discharge the referral or direct the reporter to apply to the sheriff for a decision as to whether or not any of the grounds exist. If this happens the child will have to appear before the sheriff at a later date. If the sheriff decides that any of the grounds do exist, the children's hearing will then discuss and consider what is best for the child, as if these grounds had been accepted. If the sheriff decides that no grounds exist the referral will be discharged.

On this first visit [redacted] & Lee were present. [redacted] The Children's Panel & the grounds of Referral were explained to both Lee & his parents. Lee accepted the grounds of Referral.

From the outset of this interview Lee's parents made me aware of the fact, that this was not the first time Lee had been in trouble. His parents spoke of two offences which occurred in Gervan when he was only eight years old. The offences were related to theft - stealing a model & stealing a Charity Bottle from a local pub. They also told of an offence in Cowdenbeath in which Lee was involved with a 17 year old youth when a tractor was stolen. Lee is described by his parents as being well behaved in the home environment. They say his behavioural problems ~~started~~ ^{began} when he went to school. He started school in Maybole & then the family moved to Gervan [redacted]

[redacted] They have only recently, in August of this year, returned to Gervan. While Lee was at Maybole Primary he had reading difficulties & it was decided to keep him back for one year. His parents say his reading improved. When Lee attended Gervan

Primary, because of occasional truanting & disruptive behaviour, he was referred to [redacted] Child Psychologist. He attended [redacted] for 2 or 3 years. He was also referred to [redacted] Psychiatrist, at a later date, when his mother requested help from her [redacted]. Lee's parents are anxious about Lee's behaviour & are anxious too about the outcome of the Children's Panel. They asked if Lee would be taken into care, I said that on several occasions they had used this as a threat against Lee. They said that on one occasion they had sent Lee to pack his case. Now they were both very anxious that care may in fact be the outcome. I tried to re-assure them about this matter. We talked about the various outcomes of Children's Panels, and about needing help with Lee.

Both parents, & the mother in particular, say they do not know how to handle Lee, and that they recognise their need for help with him. Lee's parents expressed the view that they have tried to discipline Lee by smacking him, but this measure proved to be ineffective. They both said they did not really approve of this method of disciplining. At the moment both parents are agreed that keeping Lee at home is a more effective measure with regard to Lee.

There have been problems in agreement between the parents about discipline & Lee in general. The mother would describe herself as over-protective, & this has caused conflict in her relationship with her husband, in the past. They now both say this conflict has been resolved.

of whom he is very fond. He also has contact regularly with his paternal grandmother in Maybale.

Lee himself was quiet at first but after about 10 minutes became quite talkative. Lee did not give any strong indication that he was aware of ^{the consequences of his actions} his actions with relation to the offences. His parents say on the one hand, that he is "sorry" and that he has been brought up to know the difference between right & wrong. At the same time they both expressed the view that in their opinion he does not appear to know this difference.

At the beginning of this interview Lee & his mother were both present. Once we had talked for about 5-10 minutes Lee seemed to be relaxed, & comfortable with the interview situation, I asked his mother to leave the room. Lee & I were alone.

I began by asking Lee about his hobbies. He talked about going swimming on Saturday's with an older cousin [redacted] & about football practice on Wednesday evenings. He did not elaborate to any great extent on either of these subjects. It was difficult to hold his attention. When I began to refer to the offences or his attitudes & behaviour at school, the situation deteriorated. Lee displayed anxiety / disinterest & I observed he had a nervous twitch.

In a one-to-one situation he was not comfortable. I did not manage to gain any really impression that he was aware of his actions, and the seriousness of the offences. His answers seemed to be standard, almost as if, his was a rehearsed response. I invited ~~I requested~~ his mother to join us in the interview.

I began by asking [redacted] to clarify points from the previous interview, e.g. schools Lee had attended [redacted]
