I write further to your previous correspondence, the contents of such are noted but not agreed.

The DSAR sent by us came with a signed Letter of Authority, signed by our client for us to conduct and obtain information on their behalf. Furthermore, we have a conditional fee agreement without a client for us to conduct the work on their behalf. By involving our client, you are going against the clients wishes and the legally binding contract between us and them.

The DSAR we sent was legally eligible and came with all relevant documentation that your institute would need to process the DSAR which was sent almost 4 weeks ago. We will call our client to clear up confusion on his end.
