| Comment           | <p>Template: <b>SBAR V4</b></p> <p>Situation Referral from Police Scotland following contact from Wesley's brother due to concerning text messages.</p> <p>Background Not currently open to Psychiatric Services.Previous inpatient admissions and overdoses.Ex-IVDU.Dx EUPD.Currently prescribed Mirtazapine and Sertraline.</p> <p>Assessment Wesley engaged well in short telephone assessment, there was no requirement for a face to face assessment in the absence of acute risk and Wesley not believing there was any issues. SBAR completed on EMIS as WinVoice not working - this will be sent to GP.Writer asked Wesley what had been going on today, he stated 'nothing'. He appeared jovial and in good spirits stating he had been feeling a bit down due to an old friend from rehab dying and him not finding out about this until much later. He stated he was feeling a bit 'fed up' and texted his brother saying he was 'sick of life' and wanted to take 'some time to himself' and turned off his phone. He feels brother has misinterpreted his text messaged and was worried about him due to previous issues with his mental health. Wesley states he has been abstinent from drugs for 3 years following rehab in Liverpool and Germany. He states he rarely drinsk alcohol and was not intoxicated at time of assessment. Wesley reports being 'fed up' due to waiting for his provisional driving license to come through and states he has been back and forward to his GP for a supporting letter to DVLA for awhile now and feels he is getting nowhere. He stated he was surprised the Police had shown up today and this was not his intentions. Writer asked Wesley what his plans were for today</p> |

and he stated he wanted to just turn his phone off and take some time to himself watching TV. He denied any thoughts of suicide or self harm. He states he sleeps well with aid of Mirtazapine. Denies any issues with appetite. He reports being prescribed Haloperidol aged 8 for tics but denies any recent tics and feels he has 'grown out of this'. He reported no issues with his mental state stating 'everything's alright' and reported just feeling a bit fed up due to no-one telling him for ages about his friend passing away. Plans to spend the day with his friend and reports might go for a walk. Pleasant and engaging during assessment, no evidence of psychosis and no risks identified.

Recommendation - Encouraged to contact NHS 24 if required.- No requirement for onwards referrals as doesn't feel there are any issues with his mental health.

Still open on Pims to alcohol services. Heas had addiction issues. Detoxed in London in Christian community.Has presented for |

psych assessemnt on several occassions since November. Most recently today. Has been commenced on quetiapine 2 days ago. Nil psychosis evident on each occasion.Seen in dept by OOH crisis CPNs D.Russell and E, Urquhart.

Assessment; Police called to tesco in Greenock. Apparently seen on CCTV ingesting paracetamol. Bloods did not corroborate this.Brother in attendance when we arrived.Assessed 6 days ago by OOH. Wesley walked out of assessment and brother became verbally hostile towards staff.Referred in to Crown House and referral discussed and rejected 30th Nov.

Seen by OOH crisis on 7th Jan, then admitted medically after overdose and seen by liaison on 10th, Seen by inverclyde crisis today. No evidence of psychosis.wesley reports that he was previously prescribed quetiapine 600mg and chlorpromazine 600mg at various points. He recalls being admitted to leverndale at some point.Believes that he was diagnosed with tourettes when a child and attended specialist assessments in Birmingham for a number of years. He said he was discharged and diagnosed with personality disorder.Poly drug use and prison .Tonight; Dressed casually in lounge wear, unshaved, sitting upright and responsive to being assessed. Full compliance and support in the process. Wearing a beannie hat which sat loosely atop his head. Overweight.Quietly spoken, maintained eye contact throughout - intense and therefore inappropriate. No sign of agitation, no distraction, no obvious thought disorder - able to converse freely and able to respond to questions appropriately.He gave an account of the voice of god telling him to take ten packets of paracetamol. He did not think it strange or that he would draw attention to himself by asking shoppers to buy him paracetamol, or to ingest them in public.Vague about the voice, but consistent with account .States that the voice was forceful. He didn't dispute the suggestion might be his own thought, but then questioned why the voice would be the same as his thought.Questioned why he sees other people who are happy and don't have god telling them the same things. Doesn't understand why people in his church are being told different things by God.Doesn't want to end his life, but maintains that he must do as god commands .Did not make any reference to secondary gain by presenting himself/ being seen repeatedly.States that voices are persistent and he has to comply.Mood subjectively and objectively seemed low. Flat affect. Offered advice that voices or thoughts may be reflective of lowered mood. Offered no reaction.No illicit substances for 1 year. Some alcohol earlier.Maintains that he has to end his life despite not wanting to. Lacks motivation to change and skills to challenge situation. has remained homeless for 3 months.Sleeps a lot. Impression; Gentleman seemed to lack skills to challenge own thoughts. Struggling with situation of homelessness. Negative thoughts. We considered the possibility that there may be an underlying mild learning disability. Seems to have difficulty or inability to differentiate between thought and 'voice'.Has been taking low dose of quetiapine for 2 days now with no obvious effect as yet.Unwilling to accept community supports as suggested by crisis inverclyde.No medication for mood prescribed at present.Maintains story that involves what could be delusional ideas which corroborate with auditory hallucinations.

Ongoing suicidal ideas with plan

Recommendation; Given frequency of attendances at A&E and GP which have raised concern resulting in psychiatric assessment, and subjective report that he has voices which collude with delusions, we have requested duty doctor provide second opinion as to what he should do tonight, and whether there is a mood or psychosis component to his presentation.Duty doc agreed to assess in A&E>
