SUBJECT ACCESS REQUEST

I am writing to you regarding your letter dated 11 May 2026, making a request for personal information on behalf of your client, Sharon Elizabeth Andrews.

I will also arrange for your request to be passed to the National Records of Scotland as the custodians of public records to conduct a search of the archives. You should expect to receive a separate response from NRS in due course.

In the meantime, the Scottish Government do not hold all files in relation to all schools and residential homes and as a result of our searches, I can confirm that we have been unable to locate any documentation based on the information you have provided.

I appreciate that this will be disappointing for your client. However, National Records Scotland will respond to you directly to inform you of the results of the search of their records and may be also in the position to provide details of other public bodies who may hold information relating to your request.
