REASON FOR REFERRAL

Include young person's view of Referral.

Jordan is being referred to your Care Centre as a result of his being outwith ^{the} Control of Care Staff in his Current Children Unit. Recently, Jordan has also been staying away from school and getting into trouble in the local Community. Jordan's views could not be ascertained at time of writing. However, parents and Care professionals are of the view that this move would be appropriate, in order to safeguard Jordan's and other people's lives.

PREVIOUS PLACEMENT DETAILS

Airth Drive Children's Unit. Jordan's Care and Safety needs is not being adequately met, in his current placement, because Jordan is refusing to comply with the boundaries put in place by staff.

PEN PICTURE OF YOUNG PERSON

Jordan is a good footballer, who is also ~~also~~ interested in Swimming. However, these good attributes could be undermined by Jordan not Channelling his talents ^{appropriately} and making use of Coaching Opportunities in the Local Community. Generally, Jordan feels he can get away with anything (act or behaviour). He is not bothered about the consequences of his actions.

Anti-Social behaviour :- Assaulting minors, Leaving the Unit without permission, Verbally abusive to staff, Staying away from school, Smoking of Cannabis, threatening behaviour, Street begging and use of aggressive sexualised language.

EDUCATION HISTORY

St. Stephen's Primary School, Sighthill, Glasgow (attendance was good and school had a positive impact on Jordan). Jordan is currently ~~at~~ ^{the} first year student of St. Roch's Secondary School.

Jordan is currently struggling at St. Roch's due to his attitude problem, his inability to cope with the school work and his numerous expulsion from school. Jordan's attendance record is currently poor.

CHALLENGING BEHAVIOURS

29/02/05: Jordan was caught behaving in a sexually inappropriate manner (rubbing himself against her) towards his younger sister.

April 2005: Damaged car of a resident in local community (Children's Reporter decided not to arrange hearing).
