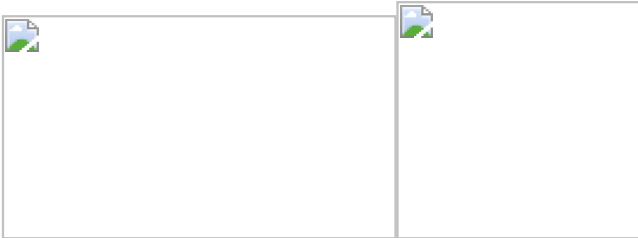

I will now undertake a search of our databases to locate any records we hold and pass these on to a member of staff to prepare for you.

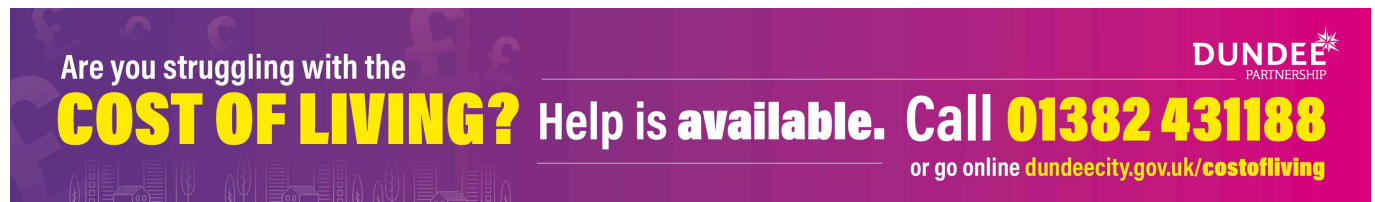
