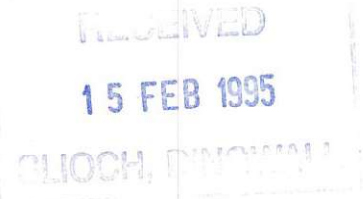

7. Mandy to seek advice from her GP regarding treatment for her psoriasis not apparently working. Grace Welsh to liase with Rossie School about the Department's medical form being completed.
8. Review in three months ie mid March 1995.

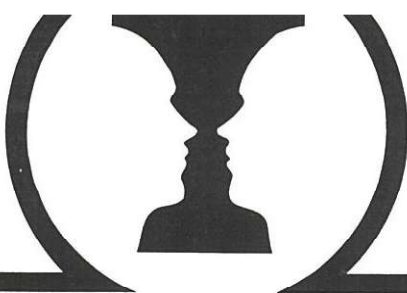

This report was prepared at the request of the Chief Executive of Rossie as part of the normal assessment process for all youngsters entering the School.

Amanda Golobek was placed in Rossie following a long history of problematic behaviour which has been extensively documented in previous professional reports. Immediately prior to placement in Rossie, Amanda's functioning caused particular concerns in respect of her absconding from care, sleeping rough, mixing with known drug abusers, her general anti-authority attitude and her sexual conduct. In interview Amanda noted that she had been placed in security because of her absconding and charges she had incurred for "different things". Amanda felt that her placement in Rossie was appropriate although the fact that her boyfriend was already in Rossie may have influenced her judgement.

At the point of entry to Rossie it was considered that Amanda's family situation was not open to change and it was thought that she might be in residence for a period in excess of three months.

Amanda's most serious problem was thought to be her exposure to moral danger followed by her involvement in offending. Amanda was not thought likely to "act out". Her most pronounced needs were considered to be the development of greater self-esteem and self-control, the provision of some stability in her life and the rekindling of some interest in her educational progress.

Within Rossie, Amanda appears to have settled quite well and generally she is quiet and posing few direct management problems. In educational terms she seems capable of some reasonable work but it remains to be seen how far she could be fully motivated in this area.



In interview on 7th June Amanda gave an apparently accurate account of her recent difficulties but was always quick to draw boundaries which she was reluctant to cross. The most basic of these concerned her family and her general lack of willingness to become involved with adults. Amanda therefore would seem to be "quiet" as a matter of differentiating between her own peer-oriented world and that of adults whom she clearly distrusts and views as interfering authority figures.

Amanda has, by her own account, been in care of one kind or another from the age of nine and she is apparently unaware of why she was initially placed in care but this probably reflects her great sensitivities about herself and her family. She attests that she likes little about Rossie but in general little about the school causes her any concern.

Staff indicate that Amanda seldom talks about herself and her feelings and when she does she says little.

Amanda has received no telephone calls or visits within Rossie and it would appear that she is effectively cut off from her family, with the occasional exception of her sister, and she appears most unlikely to talk about this.

Overall therefore Amanda seems likely to pose no substantive management problems but she is unlikely to respond to professional attempts to have her address her "problems" in any direct manner although it is clear that her "problems" are essentially real. She presently appears to be compulsively drawn to her peer group and in particular to her boyfriend. Unfortunately, it seems reasonable to assume that much of Amanda's more recent problematic behaviour has occurred as a result of her peer group involvement. She clearly has a great deal of trust in her peers and in large measure this seems quite idealised in some cases which might well be understandable but will inevitably lead to some difficult times ahead.

Overall Amanda presently seems suspicious of engagement with adults and she is essentially engaged with her peers. She seems likely to stabilise her behaviour patterns within security and to be given some time to reflect upon her overall situation. How far she can usefully utilise this time and in due course become more purposefully anchored within her home community presently remains an open question.
