Thank you for providing the names of your client James Patterson's siblings.

I can confirm that Glasgow Records Management Centre generally stipulate that to enable them to undertake a search of historical records the name and date of birth of the individual is required by them. Therefore, it would be beneficial for Mr Patterson to obtain the dates of birth of his siblings, where possible, to ensure that an accurate search can be undertaken by Glasgow Records Management Centre for your client's personal data within his siblings files, should they be held.

Can you let us know if it is possible for Mr Patterson to obtain the DOBs of his siblings please. If this is absolutely not possible, please let us know and we will contact Glasgow Records Management Centre to ask them to run a final search based on Mr Patterson's siblings names only.

Hi Daniel

Thank you for getting back to us.

I can confirm, as noted in my email of 04/08/2026 (attached) we can request a search with our Glasgow Records Management Centre for your client's siblings Social Work records to identify if any of his personal data is held within these records. However, as Mr Patterson is unable to provide names and dates of birth of his siblings Glasgow Records Management Centre will be unable to carry out this additional search. Mr Patterson's mother's name and DOB was provided to us in the search Glasgow Records Management Centre undertook for the Council when Mr Patterson's representative applied for his Social Work records in 2023 and I can confirm that this search returned no records held by the Council relating to Mr Patterson.

Unfortunately, as Mr Patterson does not remember his sibling's names and DOBs, a search for his personal data within their social work files (should they exist) cannot be undertaken.

We have therefore closed the case file Ref. SAR/2026/202 for this Subject Access Request.
