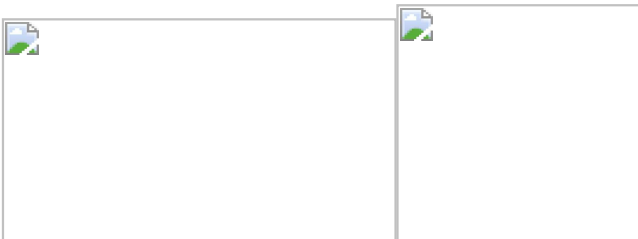
If we fail to be in receipt of a response, we will have to escalate the matter to the ICO.
